# 2024 Year in Review

When I interviewed for the role of Executive Director at Defiance County Economic Development, I was asked a pivotal question by the hiring committee, "What kind of approach would you take as the leader of this organization?" My response, I believe, caught them off guard.

I paused for a moment and asked, "Have any of you seen the movie Moneyball with Brad Pitt?" A few chuckles followed, but then I shared what I meant. I explained an approach dubbed "Money Ball Economic Development" it's rooted in reinvention—one that challenges the norm, leverages data-driven strategies, and maximizes untapped potential. That same mindset has since helped Defiance County achieve goals we once thought were out of reach.

In the movie, which was based on a true story, General Manager Billy Beane played by Pitt- turned the 2002 Oakland A's into a winning team despite the smallest total team salary in major league baseball. He didn't look at how many homeruns players hit, but rather their on-base averages.

Like Beane, we have the opportunity to rethink how we approach growth. When I began to dig into data and statistics in economic development, I saw myself as a kind of "Billy Beane" for the community. Instead of solely chasing large-scale investments, I started focusing on the untapped potential right in front of us—our existing, family-owned businesses. These generational businesses are the backbone of our local economy. If they thrive, our community thrives. They hold immense, often overlooked value. But the key is data. If we're not paying attention to the numbers, we're missing insights and opportunities to strengthen these pillars of our economy.

Beane showed us that real change requires challenging old ways of thinking. It demands a willingness to focus on what others overlook. If we, as leaders, channel that same mindset, we can build unstoppable momentum for our local economies. The data is there. All we need to do is pay attention and act.

And when our local businesses are taken care of, the grand slam opportunities see that our community is a great place to do business, and then they soon follow. Enter the 2024 announcement of Metal X coming to Defiance, Ohio.

At Defiance County Economic Development, we have a metric goal dechboard that tracks everything from median bousehold.

At Defiance County Economic Development, we have a metric goal dashboard that tracks everything from median household income, job placements, local business expansions, housing units, and more.

So, how did we stack up in 2024? Below are some of our metrics pulled from our Money Ball Metric Dashboard:

- Our office assisted businesses with over \$370 million in new investment, this doesn't include those business leaders who made the decision to push forward without assistance/incentives.
  - Since 2021, our team has assisted in bringing over \$980,000,000 in new investment.
- We have 580 new high-paying positions to be created within a 3-year period. These are all confirmed new positions coming to Defiance County.
- We reached out to over 50 housing developers to gain interest in Defiance County.
- We have over 400 new housing units coming to the market beginning in 2025.
- We made over 250 unique business visits locally.
- The Median Income of Defiance County is hovering around \$72,000 to \$68,000. Three years ago, it was \$58,000.
- We placed over 250 individuals into employment opportunities.
- We held 6 successful Educational Bus Tours, where we took students and teachers for tours of our local manufacturing/healthcare systems.
- We assisted our county/region in obtaining over \$19.6 million in grants.

So, to sum up, 2024 was a remarkable year, and 2025 is looking to shape up well, too. Moneyball Economic Development is a universal principle for unlocking full potential in all fields and all aspects of our county's economics. And it is certain to make Defiance County prosperous for generations to come. All we need to do is continue to pay close attention to the data.

# Strategic Location



#### By Road

- The City of Defiance is conveniently located within a 45-minute drive of both Toledo, Ohio, and Fort Wayne, Indiana. Defiance County is centrally located between markets in Cleveland, Cincinnati, Indianapolis, Columbus, Detroit and Chicago.
- The City of Defiance features four interchanges with U.S. Route 24, the major highway connecting Fort Wayne and Toledo. State Routes 18, 15, 66, 111 and 281 also intersect in the city.
- US 127 and State Route 18 intersect in the Village of Sherwood and State Routes 18, 49, and 2 pass through the Village of Hicksville. The Ohio Turnpike (I-80/I-90) spans the state from east to west and is less than twenty miles from the City of Defiance and the Village of Hicksville. Eleven truck lines provide intrastate and interstate shipping.

#### By Air

- Toledo Express and Fort Wayne International Airports, served by several national and international airlines, are located within an hour's drive from Defiance County.
- The Defiance County Memorial Airport features a 4,200-foot PLASI lighted runway with instrument approach and provides facilities for corporate and private aircraft.

#### **By Rail**


• Patriot Rail and CSX Railroad serve Defiance County's rail needs, with an Amtrak station located in neighboring Williams County.







# **Incentive Programs**

Tax Increment Financing (TIF)

Redirects real property tax to local government to finance public infrastructure. Defiance County offers up to 75% exemption of real property taxes for up to 10 years; however, the rate and term of TIFs can be extended up to 100% for up to 30 years with approval.

Job Creation Incentive Programs (JCIP)

A local business cash incentive which redirects a portion of local income tax back to companies that create jobs inside the city or village's corporation limits. The amount of the grant returned to the company through JCIP is based on the number of jobs created and the aggregate new annual payroll developed by the firm. The City of Defiance, Village of Sherwood, and Village of Hicksville each have their own JCIP.

Community Reinvestment Areas (CRAs)

The CRA program provides tax exemptions for new construction and remodeling projects in commercial, industrial, and residential areas. Four locations in Defiance have been designated as CRAs with tax exemptions ranging from 5 to 15 years.

Enterprise Zone Agreements

An Enterprise Zone Agreement offers special tax incentives to businesses that invest in capital improvements and create or retain jobs. Defiance County offers up to 100% abatement for 10 years on projects, as measured by their investment and employment numbers. Each contract must be approved by the affected School Districts, Township Trustees, Villages and/or the City of Defiance, and the Defiance Board of Commissioners.

CIC Business Development Loan Fund (BDLF)

The Business Development Loan Fund is controlled by the Community Improvement Corporation. It provides capital in the form of direct loans to businesses looking to create or expand operations within the City of Defiance. The BDLF is not a primary lending source and requires a partnership with other lenders and equity owners to qualify for consideration. Creation or retention of jobs is a program objective.

- Defiance County Infrastructure Revolving Loan Fund Program

  This program offers low cost loans to assist with needed public infrastructure. It is available for industrial or distribution projects. Public entities are the preferred applicants.
- Energy Special Improvement District (ESID)

  This program provides owners (private or public) the ability to finance energy efficient enhancements to their property. An eligible project is funded through Property- Assessed Clean Energy (PACE) financing. 100% funded upfront with fixed rates.

# Homegrown Grant Program



#### Program Overview:

Our board is looking for passion, as well as business smarts. Eligibility is open to small businesses located in Defiance County, Ohio, with annual revenues not exceeding \$250,000. We have set aside \$10,000 each year for this initiative, and once these funds are distributed, the next round will begin the following calendar year. Award amounts will be \$500, and these will be granted quarterly following a review by the Homegrown Board.

- Applicant is required to fill out our online application.
- Small business must be in Defiance County, Ohio
- Annual revenues not exceeding \$250,000
- Must provide your most recent Balance Sheet and Profit & Loss Financial Documents
- Applicants must have their business registered with the State of Ohio, to be eligible.
- Must meet with Lisa Becher (Nwohiosbdc@gmail.com) with Northwest State's Small Business Development Center
  - The goal of this meeting is to develop a business plan or growth plan. This is a service with no cost and great benefits to make sure you are prepared to start your business or scale up your existing business
- Awardees will be required to provide receipts or invoices for the funds allocated.
- This award can only be applied for once per year.


